

**MACON COUNTY SCHOOL BOARD CANDIDATE PETITION AND FILING  
INFORMATION  
APRIL 2, 2019 CONSOLIDATED ELECTION**

All candidates for Macon County School Boards headquartered in Macon County will file their Statement of Candidacy, petitions, and Economic Interest Statement with the Macon County Clerk's Office.

- **FIRST DAY TO CIRCULATE PETITIONS IS TUESDAY, SEPTEMBER 18, 2018**
- School Board candidate's signature requirement is 50 qualified voters residing within the school district. PLEASE NUMBER YOUR PETITION PAGES.
- Candidate must complete a Statement of Economic Interest. The stamped receipt must be attached to your completed Statement of Candidacy.

The Statement of Candidacy must include the following information in the "Office" section at the top of the form:

1. The School District name and the words Board of Education which indicates the office they are running for.
2. The candidate must state whether they are seeking a full term or an unexpired 2-year term.
3. Argenta-Oreana, Maroa-Forsyth and Warensburg-Latham School District Candidates must indicate the correct Congressional Township and Range in which they reside.
4. Mt. Zion School District candidates must indicate whether they reside in an incorporated or unincorporated area of said district.

**Filing Dates for Nominating Papers:**

Monday, December 10, 2018 beginning at 8:00 a.m. until 4:30 p.m.

Tuesday-Friday, December 11-14, 2018 - 8:30 a.m. until 4:30 p.m.

Monday, December 17, 2018 - 8:30 a.m. until 5:00 p.m.

If more than one candidate from the same school district files at 8:00 a.m. on Monday, December 10<sup>th</sup> a lottery will be held to determine who will be listed first on the ballot.

If more than one candidate from the same school district files between 4:00 p.m. and 5:00 p.m. on Monday, December 17<sup>th</sup>, a lottery will be held to determine the candidate listed last on the ballot.

## **BOARDS OF EDUCATION**

**OFFICE:** Board of Education Member

**QUALIFICATIONS:** Qualified elector/registered voter and shall not be a child sex offender as defined in Section 11-9.3 of the Criminal Code of 2012.  
(105 ILCS 5/10-10)

**RESIDENCY:** Any person who, on the date of election, is a U.S. citizen of the age of 18 or over and a resident of the State and the territory encompassing the district for one year preceding the election is eligible. A member cannot serve as a school trustee.  
(105 ILCS 5/10-10)

**SIGNATURE REQUIREMENTS:** Petitions must be signed by at least 50 qualified voters or 10% of the voters, whichever is less, residing within the district.  
(105 ILCS 5/9-10)

**PETITION:** Board of Education petition (at large) SBE Form P-7  
Board of Education petition (district 1 - 7) SBE Form P-7A

**STATEMENT OF CANDIDACY:** Filed with the nominating petitions. Nonpartisan SBE Form P-1A.

**LOYALTY OATH:** (Optional) Filed with the nominating petitions. SBE Form P-1C.

**STATEMENT OF ECONOMIC INTERESTS:** Filed with the county clerk of the county in which the principal office of the unit of local government with which the person is associated is located. See page 19 regarding the filing of the receipt.  
(5 ILCS 420/4A-106)

**FILING DATES:** December 10 – 17, 2018 (not more than 113 nor less than 106 days prior to the Consolidated Election).

**WHERE TO FILE:** Filed with the county clerk or the county board of election commissioners, as the case may be, of the county in which the principal office of the school district is located. (105 ILCS 5/9-10)

**CAMPAIGN DISCLOSURE:** Reports must be filed either on paper or electronically with the State Board of Elections, 2329 S. MacArthur Blvd., Springfield, IL 62704 or 100 West Randolph Street, Suite 14-100, Chicago, IL 60601.

**FAIR CAMPAIGN PRACTICES ACT:** Filed with the county clerk. (Voluntary - see page 20)
